RESOLUTION 2025-86

RESOLUTION APPROVING THE SANGGUNIANG BAYAN COMMITTEES AS PER RULE X, SECTION 12 OF THE APPROVED INTERNAL RULES OF PROCEDURE (IRP) OF THE SANGGUNIANG BAYAN, PAVIA, ILOILO FOR 2025-2028.

WHEREAS, Section 50 of RA 7160 otherwise known as the "Local Government Code of 1991" mandates that the Sanggunian shall adopt or update its existing Internal Rules of Procedure (IRP) within ninety (90) days of the first regular session following the election of its members;

WHEREAS, the Sangguniang Bayan of Pavia, Iloilo is a legislative body duly organized pursuant to law for the enactment of ordinances and the adoption of resolutions for the governance of the Municipality of Pavia, Iloilo;

WHEREAS, Article 103 of the Rules and Regulations Implementing the Local Government Code of 1991 provides that local legislative bodies have the inherent right and obligation of adopting its own rules of procedure for the proper discharge of legislative functions;

WHEREAS, in the maintenance of good order and pursuant to its legislative functions, it is necessary that specific rules be adopted and enforced in its deliberations in the interest of effective legislation;

WHEREAS, Rule X of the said IRP provides for the standing committees and its composition;

NOW THEREFORE, on motion of Hon. Joshua Philippe B. Gumban and duly seconded unanimously,
