RESOLUTION AUTHORIZING HONORABLE LAURENCE ANTHONY G. GORRICETA, MUNICIPAL MAYOR, MRS. CAROLINE T. TERUEL, MUNICIPAL TREASURER, AND HONORABLE EDSSEL G. GEROCHI, MUNICIPAL VICE MAYOR (AS OFFICIAL SIGNATORY WHILE THE MUNICIPAL MAYOR IS ON-LEAVE), TO BE THE OFFICIAL SIGNATORIES FOR AND IN BEHALF OF THE MUNICIPALITY OF PAVIA, ILOILO IN RELATION TO THE OFFICIAL BANK ACCOUNTS OF THE LOCAL GOVERNMENT UNIT OF PAVIA, ILOILO.

WHEREAS, presented for consideration of the August Body is the request from the Office of the Mayor for the above-mentioned measure;

WHEREAS, a resolution for the immediate updating and reaffirmation of specimen signatures of authorized signatories for the official bank accounts of the Municipality of Pavia, Iloilo is needed in compliance with procedural requirements following the recently concluded national and local elections;
