RESOLUTION FORWARDING TO THE (1) OFFICE OF THE MUNICIPAL MAYOR, AND (2) THE MUNICIPAL LOCAL GOVERNMENT OPERATIONS OFFICER (MLGOO) OF THE DILG THE HEREIN IC-OVI-JAN-25-0007 (ADMINISTRATIVE ASPECT OF THE ATTACHED COMPLAINT OF MS. MA. DEZA MAE M. CALUGAS, BARANGAY TIGUM, PAVIA, ILOILO, AGAINST FERDINAND ALDEA GUILLEM, PUNONG BARANGAY, TIGUM, PAVIA, ILOILO, PURSUANT TO SECTION 3 AND 4, RULE 3 OF THE MUNICIPAL ORDINANCE 2014-02 FOR THE SANGGUNIAN EXERCISE OF JURISDICTION REGARDING THE COMPLAINT.

WHEREAS, presented for consideration of the August Body during the Regular Session dated July 14, 2025 is the letter from the Office of the Ombudsman relative to IC-OVI-JAN-25-0007(MS. MA. DEZA MAE M. CALUGAS vs FERDINAND A. GUILLEM);

WHEREAS, the Sangguniang Bayan of Pavia, Iloilo has original jurisdiction over administrative disciplinary cases against barangay officials within the Municipality of Pavia, Iloilo pursuant to Section 60 to 68 of RA 7160, otherwise known as the Local Government Code of 1991, in relation to Articles 124 to 132 of the Rules and Regulations Implementing the Local Government Code of 1991;

WHEREAS, the Sangguniang Bayan of Pavia, Iloilo having the disciplinary power over elective barangay officials within its territorial jurisdiction enacted Municipal Ordinance 2014-02 dated August 11, 2014 titled "Rules of Procedures in the Conduct of Administrative Investigation by the Sangguniang Bayan of Pavia, Iloilo", hereto attached as "ANNEX B";

WHEREAS, Rule 3 provides:

Section 3: "A copy of the complaint shall be furnished by the complainant to each of the following:

- a) The Office of the Municipal Mayor;
- b) The Municipal Local Government Operations Officer (MLGOO) of the DILG assigned at the municipality.

No complaint shall be accepted unless the foregoing requirements are complied, with proof of service that copies were furnished to the Municipal Mayor and the MLGOO of the DILG

Section 4. Complaint filed with other agency.- If a complaint is filed with another government agency, the same maybe referred to and accepted by the Sanggunian, provided, it complies with all the requirements as provided in the immediate two (2) preceding sections.

WHEREAS, in compliance thereto, the Secretariat is directed to send copies to the above-mentioned office, ensuring to secure proof of service that copies were duly furnished;

NOW THEREFORE, on motion of Honorable Joshua Philippe B. Gumban and duly seconded by Honorable Jo Jan Paul J. Peñol;

RESOLVED FURTHER, that copies of this resolution be furnished to all concerned entities/agencies for information and appropriate action.


