RESOLUTION 2025-99

RESOLUTION DESIGNATING HONORABLE JOEFRITZ C. COLLADO AS THE SANGGUNIANG BAYAN REPRESENTATIVE TO THE PEOPLE'S LAW ENFORCEMENT BOARD (PLEB) OF THE MUNICIPALITY OF PAVIA, ILOILO.

WHEREAS, Section 43 of Republic Act Number 6975 otherwise known as the Department of the Interior and Local Government Act of 1990 provided for the creation of People's Law Enforcement Board in every municipality to conduct hearing and adjudication of citizen's complaints against uniformed members of the Philippine National Police (PNP) for the offenses committed in their area of jurisdiction;

WHEREAS, Rule II, Section 3 of NAPOLCOM Memo 2001-01 states that "The PLEB shall be composed of the following:

- a) Any member of the Sangguniang Bayan chosen by his/her respective sanggunian;
- b) Any punong-barangay of the municipality concerned chosen by the Liga ng mga Barangay; and

- c) Three (3) other members who are removable only for cause to be chosen by the Local Peace and Order Council from among the respected members of the community known for their probity and integrity, one (1) of whom must be a woman and another, a member of the BAR, or in the absence thereof, a college graduate, or the principal of the central elementary school in the locality.

NOW THEREFORE, on motion of Honorable Joshua Philippe B. Gumban and duly seconded by Honorable Leonardo L. Belasa;


