RESOLUTION 2025-132-A

RESOLUTION APPROVING AND GRANTING THE ACCREDITATION OF NEGROS WOMEN FOR TOMORROW FOUNDATION IN THE MUNICIPALITY OF PAVIA, ILOILO PURSUANT TO DILG MEMORANDUM CIRCULAR 2025-060 DATED JUNE 23, 2025.

WHEREAS, Section 34 of the Local Government Code of 1991 provides that the local government units shall promote the establishment and operation of people's and non-government organizations to become active partners in the pursuit of local autonomy;

WHEREAS, strengthening partnerships with the Civil Society Organizations (CSOs) is necessary to empower citizens to articulate their needs as they participate in the decision-making process, program planning, implementation, monitoring, and evaluation at the local level which can increase the responsiveness and efficiency of local governments in delivering services;

WHEREAS, the Department of the Interior and Local Government issued Memorandum Circular 2025-060 dated June 23, 2025 on the process for accreditation which was made as reference by the SB Committee on People's Organizations and Cooperatives;

WHEREAS, **NEGROS WOMEN FOR TOMORROW FOUNDATION** has signified intention to be an accredited CSO in the Municipality of Pavia, Iloilo to pursue an active

partnership with the Local Government Unit in the pursuit of local autonomy and nation building;

WHEREAS, NEGROS WOMEN FOR TOMORROW FOUNDATION has satisfactorily complied with the requirements and criteria for accreditation as a civil society organization in accordance with the procedures and guidelines set forth in DILG MC 2025-060;

NOW THEREFORE, on motion of Honorable Ariel B. Gerada and duly seconded by Honorable Gerard Peter G. Zaldarriaga,


RESOLVED, as it is hereby resolved, to pass a resolution approving and granting the accreditation of **NEGROS WOMEN FOR TOMORROW FOUNDATION** in the Municipality of Pavia, Iloilo pursuant to DILG Memorandum Circular 2025-060 dated June 23, 2025.

RESOLVED FURTHER, that this accreditation is effective only until June 30, 2028.

RESOLVED FURTHERMORE, that copies of this resolution be forwarded to all concerned agencies for information and appropriate action.
