**RESOLUTION NO. 2025-137**

**RESOLUTION DECLARING "BARANGAY BALABAG ORDINANCE NO. 003, SERIES OF 2025 "AN ORDINANCE IMPOSING A REGULATED FILING FEE OF THREE HUNDRED PESOS (P300.00) FOR FORMAL COMPLAINTS FILED BEFORE THE BARANGAY LOCAL GOVERNMENT OF BALABAG, PAVIA, ILOILO", AS LEGAL AND VALID.**

**WHEREAS**, pursuant to Section 16 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, every local government unit shall exercise powers necessary, appropriate, or incidental for its efficient and effective governance, and which are essential to the promotion of the general welfare;

**WHEREAS**, further under Section 57 of the same Code, the Sangguniang Bayan shall review all ordinances enacted by the Sangguniang Barangay to ensure

that these are within the powers granted by law, consistent with municipal and national legislation, and enacted for the benefit of the constituents;

**WHEREAS**, the Sangguniang Bayan of Pavia, Iloilo, in the exercise of its review function, has examined the:

**Barangay Balabag Ordinance No. 003, Series of 2025**

**“An Ordinance Imposing a Regulated Filing Fee of Three Hundred Pesos (₱300.00) for Formal Complaints Filed before the Barangay Local Government of Balabag, Pavia, Iloilo.”**

**WHEREAS**, upon careful review, the Sangguniang Bayan finds that the above ordinances are within the powers of the Barangay Council to enact.

**WHEREAS**, the SB Committee on Good Government recommended for its approval as indicated in Committee Report 2025-136 dated September 8, 2025;

**NOW, THEREFORE**, on motion of Honorable Joshua Philippe B. Gumban, which was duly seconded by Honorable Jo Jan Paul J. Peñol;

**RESOLVED**, as it is hereby resolved to pass a *Resolution Declaring “Barangay Balabag Ordinance No. 003, Series of 2025 “An Ordinance Imposing a Regulated Filing Fee of Three Hundred Pesos (₱300.00) for Formal Complaints Filed before the Barangay Local Government of Balabag, Pavia, Iloilo”, as legal and valid.*
