**WHEREAS**, in honoring their dedication for work, may other education personnel all over Pavia and the country be inspired to always strive for excellence for the future generations;


**NOW THEREFORE**, on motion of Honorable Jo Jan Paul J. Penol and duly seconded unanimously;
