MUNICIPAL ORDINANCE 2025-33

ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE ALONG SUMAKWEL STREET FROM STA. MONICA CATECHETICAL LEARNING SCHOOL TO THE PAVIA MULTI-PURPOSE GYM, EXTENDING TO THE CORNER OF HEDRIANA STREET AND THE BACK OF THE CETENNIAL BUILDING, NIGHTLY FROM DECEMBER 16 TO DECEMBER 23, 2025, FROM 4:00 PM TO 3:00 AM, IN CONNECTION WITH THE "PASKUA SA PAVIA 2025" FOODFEST SPEARHEADED BY THE LOCAL EMPLOYEES ASSOCIATION OF PAVIA (LEAP).

WHEREAS, there is a necessity for the temporary closure of portions of the above-mentioned roads to ensure the peace, order, and security during the "PASKUA SA PAVIA 2025 FOODFEST";

WHEREAS, Local Government Code of 1991, Section 21 (Closure and Opening of Roads) provides:

- (a) A local government unit may, pursuant to an ordinance, permanently or temporarily close or open any local road, alley, park, or square falling

within its jurisdiction: Provided, however, That in case of permanent closure, such ordinance must be approved by at least two-thirds (2/3) of all the members of the Sangguniang, and when necessary, an adequate substitute for the public facility that is subject to closure is provided.

- (b) No such way or place or any part thereof shall be permanently closed without making provisions for the maintenance of public safety therein. A property thus permanently withdrawn from public use may be used or conveyed for any purpose for which other real property belonging to the local government unit concerned may be lawfully used or conveyed: Provided, however, that no freedom park shall be closed permanently without provision for its transfer or relocation to a new site.
- (c) Any national or local road, alley, park, or square may be temporarily closed during an actual emergency, or fiesta celebrations, public rallies, agricultural or industrial fairs, or an undertaking of public works and highways, telecommunications, and waterworks projects, the duration of which shall be specified by the local chief executive concerned in a written order: Provided, however, That no national or local road, alley, park, or square shall set temporarily closed for athletic, cultural, or civic activities not officially sponsored, recognized, or approved by the local government unit concerned.

WHEREAS, it is recommended that the Organizer shall:

1. Coordinate with the PSTMO, barangay officials, and local police to ensure proper deployment of personnel, crowd control, and traffic management;
2. Conduct advanced public information dissemination, to inform residents, motorists, and affected stakeholders of the scheduled road closure and available alternate routes;
3. Comply with all safety protocols and logistical requirement imposed by relevant authorities;

WHEREAS, the organizer is required to execute a waiver with the Local Government Unit (LGU), explicitly stating that the Local Government shall not be held liable for any incidents, issues, or problems that may arise during the event;

WHEREAS, the SB Committee on Transportation recommended for its approval as indicated in Committee Report 2025- 150 dated December 9, 2025;

NOW THEREFORE, PREMISES CONSIDERED, AND UPON THE RECOMMENDATION OF THE SB COMMITTEE ON TRANSPORTATION, BE IT ORDAINED by the Sangguniang Bayan of Pavia, Iloilo in a regular session duly assembled, that:

Section 1. ORDINANCE AUTHORIZING THE TEMPORARY CLOSURE ALONG SUMAKWEL STREET FROM STA. MONICA CATECHETICAL LEARNING SCHOOL TO THE PAVIA MULTI-PURPOSE GYM, EXTENDING TO THE CORNER OF HEDRIANA STREET AND THE BACK OF THE CETENNIAL BUILDING, NIGHTLY FROM DECEMBER 16 TO DECEMBER 23, 2025, FROM 4:00 PM TO 3:00 AM, IN CONNECTION WITH THE "PASKUA SA PAVIA 2025" FOODFEST SPEARHEADED BY THE LOCAL EMPLOYEES ASSOCIATION OF PAVIA (LEAP).

Section 2. The PPSTMO, Pavia PNP and barangay concerned be furnished copies of this ordinance for their information and appropriate action. The enforcement of the closure shall be subject to the prior announcement or information dissemination at the expense of the organizers for at least three (3) consecutive days prior to the scheduled closure.


Section 3. This ordinance shall take effect upon approval.

BE IT ORDAINED FURTHER, to furnish copies of this Ordinance to the Sangguniang Panlalawigan of the Province of Iloilo for review, and other concerned agencies for information and appropriate action.


ENACTED this 9th day of December, 2025 at Pavia, Iloilo, Philippines.
