RESOLUTION AUTHORIZING THE ESTABLISHMENT OF A BUST AND COMMEMORATIVE MARKER IN HONOR OF THE LATE HONORABLE ARCADIO H. GORRICETA, FORMER MUNICIPAL MAYOR OF PAVIA AND FORMER REPRESENTATIVE OF THE SECOND DISTRICT OF ILOILO, AT THE PAVIA MULTI-PURPOSE GYM FIELD, TO GIVE HONOR TO HIS INVALUABLE CONTRIBUTION TO THE DEVELOPMENT OF MUNICIPALITY OF PAVIA AND THE ENTIRE 2ND DISTRICT OF ILOILO.

WHEREAS, the late Honorable Arcadio H. Gorriceta is one of the most respected and admired leaders of the Municipality of Pavia and the Province of Iloilo;


