RESOLUTION NO. 2025-168

RESOLUTION AUTHORIZING HONORABLE JOSHUA PHILIPPE B. GUMBAN, MUNICIPAL COUNCILOR, PAVIA, ILOILO TO SUBMIT RESOLUTION NO. 2025-155, 2025-156, AND 2025-157 TO THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) CENTRAL OFFICE, THE SENATE COMMITTEE ON ACCOUNTABILITY OF PUBLIC OFFICERS AND INVESTIGATIONS (BLUE RIBBON COMMITTEE), AND THE OFFICE OF THE PRESIDENT THROUGH THE INDEPENDENT COMMISSION ON INFRASTRUCTURE (ICI), TO CONDUCT AN INVESTIGATION AND REVIEW OF THE STATUS, IMPLEMENTATION, AND UTILIZATION OF FUNDS FOR THE AGANAN FLYOVER PROJECT AND OTHER ONGOING NATIONALLY-FUNDED INFRASTRUCTURE PROJECTS IN THE MUNICIPALITY OF PAVIA, ILOILO.

WHEREAS, the Aganan Flyover Project located at Barangay Aganan, Pavia, Iloilo, implemented by the Department of Public Works and Highways (DPWH) through the International Builders Corporation (IBC), commenced construction on July 6, 2020, with an approved budget of ₱560,000,000.00 and a contract duration of twenty-four (24) months;

WHEREAS, despite the lapse of the original construction period and the allocation of substantial public funds, the said project remains unfinished and non-operational, resulting in persistent traffic congestion, public inconvenience, and adverse socio-economic effects on the residents and commuters of Pavia and nearby municipalities;

WHEREAS, several hearings were conducted by the Sangguniang Bayan of Pavia through its Committee on Transportation, regarding unresolved issues such as

misaligned girders, vertical displacement, flooding, defective engineering design, and the absence of a clear completion timeline or transparent remedial plan;

WHEREAS, on September 22, 2025, the Sangguniang Bayan of Pavia passed Resolution No. 2025-155, 2025-156, and 2025-157, which respectively call for the completion, investigation, and accountability review of the Aganan Flyover Project and other nationally-funded infrastructure projects within the Municipality of Pavia, Iloilo;

WHEREAS, in the interest of good governance, fiscal responsibility, and public welfare, there is a compelling need to elevate the matter to higher oversight authorities such as the DPWH Central Office, the Senate Blue Ribbon Committee, and the Office of the President through the Independent Commission on Infrastructure (ICI), for a comprehensive investigation and review of the project's implementation, fund utilization, and present status;

WHEREAS, Honorable Joshua Philippe B. Gumban, a Member of the Sangguniang Bayan of Pavia, Iloilo and chairperson of the SB Committee on Good Government expressed his willingness to formally transmit said resolutions to the concerned national government offices;

NOW, THEREFORE, on motion of Honorable Daniel S. Fajardo, II, duly seconded unanimously,

RESOLVED, as it is hereby resolved, to pass a resolution authorizing Honorable Joshua Philippe B. Gumban, Municipal Councilor, Pavia, Iloilo to submit Resolution No. 2025-155, 2025-156, and 2025-157 to the Department of Public Works and Highways (DPWH) Central Office, Senate Committee on Accountability of Public Officers and Investigations (Blue Ribbon Committee), and Office of the President through Independent Commission on Infrastructure (ICI), to conduct an investigation and review of the status, implementation, and utilization of funds for the Aganan Flyover Project and other ongoing nationally-funded infrastructure projects in the Municipality of Pavia, Iloilo.


RESOLVED FURTHER, that copies of this resolution be furnished to the Office of the President, the Independent Commission on Infrastructure (ICI), the Department of Public Works and Highways (DPWH) – Central Office, Office of the Municipal Mayor-Pavia, Iloilo, and other relevant agencies for their information and action.
