RESOLUTION AUTHORIZING HONORABLE LAURENCE ANTHONY G. GORRICETA, MUNICIPAL MAYOR, PAVIA, ILOILO TO ENTER AND SIGN THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY OF PAVIA, ILOILO AND ST. PAUL'S HOSPITAL OF ILOILO, INC. IN LINE WITH THE POST-GRADUATE INTERNSHIP PROGRAM OF THE COLLEGE OF FAMILY AND COMMUNITY MEDICINE.

WHEREAS, the Municipality of Pavia, Iloilo, recognizes the importance of strengthening partnerships with educational and medical institutions to promote community health development and provide opportunities for medical training and public service;

WHEREAS, St. Paul's Hospital of Iloilo, Inc., through its College of Family and Community Medicine, has initiated a Post-Graduate Internship Program designed to provide practical field experience and community exposure to medical interns;

WHEREAS, the said partnership aims to enhance the delivery of primary health care services in the Municipality of Pavia while providing learning opportunities for interns under the supervision of qualified medical professionals;

WHEREAS, the proposed Memorandum of Agreement (MOA) between the Municipality of Pavia and St. Paul's Hospital of Iloilo, Inc. outlines the respective roles, commitments, and responsibilities of both parties in implementing the internship program;

WHEREAS, it is necessary to authorize the Local Chief Executive to enter and sign the said MOA on behalf of the Municipality of Pavia, Iloilo, to formalize the partnership and ensure proper coordination in its implementation;

WHEREAS, the Sangguniang Bayan Office shall be furnished the signed copy of the said MOA for documentation purposes;

NOW, THEREFORE, on motion of Honorable Jo Jan Paul J. Peñol, which was duly seconded by Honorable Gerard Peter G. Zaldarriaga;

RESOLVED, as it is hereby resolved to pass a *resolution authorizing Honorable Laurence Anthony G. 
