RESOLUTION 2025-176

RESOLUTION CONCURRING THE APPOINTMENT OF MRS. CHELSEA B. GADOT AS MUNICIPAL ACCOUNTANT AT THE MUNICIPAL ACCOUNTING OFFICE OF THE MUNICIPALITY OF PAVIA, PROVINCE OF ILOILO EFFECTIVE OCTOBER 1, 2025.

WHEREAS, Section 481 of RA 7160 provides that every municipality shall have a Municipal Accountant who shall take charge of both accounting and internal audit services of the local government unit, and whose qualifications, powers, and duties shall be in accordance with existing civil service laws and regulations;

WHEREAS, the Civil Service Commission (CSC) laws, rules, and regulations prescribe that appointments to career service positions shall be based on merit and fitness, determined through a competitive process ensuring the appointee meets all required qualifications;

WHEREAS, the Department of Budget and Management (DBM) Circulars and Local Budget Memoranda provide guidelines on the creation, classification, and compensation of local positions, including the position of Municipal Accountant;

WHEREAS, the Local Chief Executive, Honorable Laurence Anthony G. Gorricketa issued an Appointment to Mrs. Chelsea B. Gadot as Municipal Accountant at the Municipal Accounting Office of the Municipality of Pavia, Province of Iloilo effective October 1, 2025;

WHEREAS, Section 443(a)(2)(vi) of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that the appointment of the heads of departments and offices by the Municipal Mayor shall be subject to the concurrence of the majority of all the members of the Sangguniang Bayan;

WHEREAS, the appointing authority certified that all the pertinent provisions of RA 7160 have been complied in connection with her appointment, and all the requirements and supporting papers have been complied with, reviewed and found to be in order;

WHEREAS, funds are available in connection with her appointment with salary grade 24/1;

NOW THEREFORE, on motion of Honorable Joshua Philippe B. Gumban and duly seconded unanimously;

RESOLVED, as it is hereby resolved, to pass a resolution concurring the appointment of Mrs. Chelsea B. Gadot as Municipal Accountant at the Municipal Accounting Office of the Municipality of Pavia, Province of Iloilo effective October 1, 2025.

RESOLVED FURTHER, that copies of this resolution be forwarded to the Office of the Mayor, Office of the Human Resource Management, all of Pavia, Iloilo; Civil Service Commission (CSC), Regional Office VI, Iloilo City; Sangguniang Panlalawigan, Provincial Capitol, Iloilo City; DILG Provincial Office and other concerned agencies for information and appropriate action.


