**RESOLUTION ADOPTING A POLICY/GUIDELINES ON THE DETERMINATION OF
THE PERCENTAGE (%) RATING OF ACCOMPLISHMENT ON THE
PHYSICAL/FINANCIAL PERFORMANCE OF OFFICES IN THE LOCAL
GOVERNMENT UNIT OF PAVIA, ILOILO.**

WHEREAS, the Sangguniang Bayan Office received a request from the Local Chief Executive for the above-mentioned resolution;

WHEREAS, the Local Government Unit of Pavia, Iloilo recognizes the need to ensure efficiency, accountability, and transparency in the implementation of Programs, Projects, and Activities (PPAs) across all departments and offices;

WHEREAS, the timely and accurate determination of Physical and Financial Performance Accomplishment is essential in monitoring progress, identifying gaps, and instituting corrective measures to guarantee the effective utilization of public resources;

WHEREAS, adopting unified and standardized guidelines on the computation and interpretation of percentage (%) rating for Physical and Financial Accomplishment will promote consistency in reporting, enhance performance evaluation, and support evidence-based decision-making;

WHEREAS, such guidelines will also serve as a basis for performance-based incentives, compliance with national government reporting requirements, and internal organizational development;

WHEREAS, through the initiative of the Internal Audit Service Unit, a meeting was convened on October 8, 2025 for the finalization of the above-mentioned updated policy and guidelines attached as "ANNEX A";

WHEREAS, such policy and guidelines will serve as an operative tool for monitoring and evaluation of performance which leads to efficiency, effectiveness, and quality of output in delivering services to the constituents;




RESOLVED FURTHER, that copies of this resolution be furnished to all concerned agencies for their perusal.
