RESOLUTION NO. 2025-179

RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY OF PAVIA, ILOILO AND THE DEPARTMENT OF HEALTH-WESTERN VISAYAS CENTER FOR HEALTH AND DEVELOPMENT, AND FURTHER AUTHORIZING THE HONORABLE LAURENCE ANTHONY G. GORRICETA, MUNICIPAL MAYOR, TO ENTER AND SIGN FOR IN BEHALF OF THE MUNICIPALITY OF PAVIA, ILOILO RELATIVE TO THE APPROPRIATED FUNDS FROM THE LOCAL HEALTH SYSTEM DEVELOPMENT ASSISTANCE (LHSDA) 2025 BUDGET AS CASH AWARDS FOR THE WINNERS OF THE LOCAL SYSTEM AWARDS.

WHEREAS, presented for consideration of the body, and referred to the SB Committee on Health is the endorsement for the above-mentioned measure;

WHEREAS, the Department of Health (DOH) – Western Visayas Center for Health and Development (WV CHD) has initiated the Local System Awards to recognize outstanding performance in local health system implementation within the region;

WHEREAS, the Municipality of Pavia, Iloilo has been identified as one of the beneficiaries of the Local Health System Development Assistance (LHSDA) 2025 budget, intended to support local health programs through incentivized awards;

WHEREAS, it is imperative to formalize the partnership and fund disbursement through a Memorandum of Agreement (MOA) between the Municipality of Pavia, Iloilo and the Department of Health – Western Visayas Center for Health and Development;

WHEREAS, to operationalize the MOA, the Honorable Laurence Anthony G. Gorriceta, Municipal Mayor of Pavia, Iloilo, must be granted authority by the Sangguniang Bayan to enter into, and sign the said Agreement for and in behalf of the Municipality;

WHEREAS, the responsibilities of both parties, and the terms and conditions are stipulated in the MOA, attached as "ANNEX A";

WHEREAS, the Sangguniang Bayan Office shall be furnished a copy of the signed MOA for documentation purposes;


NOW, THEREFORE, on motion of Honorable Rhia B. Sotomil, and duly seconded by Honorable Ariel B. Gerada,
