**RESOLUTION APPROVING THE MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE MUNICIPALITY OF PAVIA, ILOILO AND THE COMMISSION ON POPULATION AND DEVELOPMENT (CPD)- REGION VI, AND FURTHER AUTHORIZING THE HONORABLE MAYOR LAURENCE ANTHONY G. GORRICETA, MUNICIPAL MAYOR, PAVIA, ILOILO TO ENTER AND SIGN FOR AND IN BEHALF OF THE MUNICIPALITY OF PAVIA, ILOILO THE MOU FOR STRENGTHENING OF PARTNERSHIP ON THE LOCALIZATION AND IMPLEMENTATION OF PPD-POA STRATEGIES WITH PAG-ASA YOUTH ASSOCIATION OF THE PHILIPPINES (PYAP) PAVIA CHAPTER.**

**WHEREAS**, presented for consideration of the body is the endorsement for the above-mentioned measure;

**WHEREAS**, the Commission on Population and Development (CPD) – Region VI, in pursuit of its mandate to address issues on population and development, continues to implement programs aligned with the Philippine Population and Development Program of Action (PPD-POA);

**WHEREAS**, the Municipality of Pavia, Iloilo, through its Local Government Unit and in collaboration with the Pag-Asa Youth Association of the Philippines (PYAP) – Pavia Chapter, seeks to strengthen youth engagement and promote population and development strategies at the local level;

**WHEREAS**, the Memorandum of Understanding (MOU) between the Municipality of Pavia, Iloilo, and CPD Region VI defines their collective commitment to localizing and implementing PPD-POA strategies in partnership with PYAP Pavia Chapter;

**WHEREAS**, the Sangguniang Bayan deems it necessary to formalize the Municipality's participation and authorize the Municipal Mayor to enter into and sign the said MOU;

**WHEREAS**, the responsibilities of both parties, and the terms and conditions are stipulated in the MOU, attached as "ANNEX A";


