WHEREAS, the Local Health Board (LHB) of the Municipality of Pavia, Iloilo convened and duly passed LHB Resolution No. 2025-06, titled "A Resolution Approving the Programs, Projects, and Activities (PPAs) for Health and Nutrition for Calendar Year 2026";


