RESOLUTION ADOPTING LOCAL HEALTH BOARD (LHB) RESOLUTION NO. 2025-07, "A RESOLUTION APPROVING THE PROGRAMS, PROJECTS, AND ACTIVITIES (PPAs) TO COMBAT HIV-AIDS FOR CALENDAR YEAR 2026"

WHEREAS, the Local Health Board (LHB) of the Municipality of Pavia, Iloilo convened and duly approved LHB Resolution No. 2025-07, titled "A Resolution Approving the Programs, Projects, and Activities (PPAs) to Combat HIV-AIDS for Calendar Year 2026";

WHEREAS, the Municipality recognizes the importance of strengthening local strategies to prevent, control, and reduce the incidence of HIV-AIDS through effective, targeted, and community-responsive interventions;

WHEREAS, the approved PPAs for Calendar Year 2026 outline key prevention, awareness, diagnosis, and support initiatives essential to safeguarding public health and promoting a healthy and informed citizenry;

WHEREAS, pursuant to Section 102 of Republic Act No. 7160, also known as the "Local Government Code of 1991," the Local Health Board is mandated to recommend health policies and advise the Sangguniang Bayan on matters pertaining to health programs, including those addressing HIV-AIDS;

WHEREAS, the adoption of LHB Resolution No. 2025-07 by the Sangguniang Bayan is necessary to ensure funding, implementation, and integration of the HIV-AIDS-related PPAs into the Municipal Annual Investment Program (AIP) and the overall local health strategy for CY 2026;


