RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) WITH THE ILOILO POLICE PROVINCIAL OFFICE (IPPO), PHILIPPINE NATIONAL POLICE (PNP) FOR THE DEPLOYMENT OF ONE (1) K9 TEAM COMPOSED OF A PNP HANDLER AND A NARCOTIC DETECTION DOG IN THE MUNICIPALITY OF PAVIA, ILOILO TO SERVE AS ORGANIC PERSONNEL OF THE PAVIA MUNICIPAL POLICE STATION, AND FURTHER AUTHORIZING HONORABLE MAYOR LAURENCE ANTHONY G. GORRICETA TO ENTER INTO AND SIGN, FOR AND IN BEHALF OF THE MUNICIPALITY OF PAVIA, THE MEMORANDUM OF AGREEMENT (MOA) WITH THE ILOILO POLICE PROVINCIAL OFFICE (IPPO) AND THE PHILIPPINE NATIONAL POLICE (PNP).

WHEREAS, the maintenance of peace and order and the protection of life and property are among the primary mandates of the local government pursuant to the Local Government Code of 1991;

WHEREAS, the Municipality of Pavia, Iloilo continues to strengthen its efforts against illegal drugs and other criminal activities through close coordination with the Philippine National Police (PNP);

WHEREAS, the Iloilo Police Provincial Office (IPPO), Philippine National Police (PNP), has proposed the deployment of one (1) K9 Team composed of a

trained PNP handler and a narcotic detection dog to the Municipality of Pavia, Iloilo to enhance police operations, particularly in the detection and prevention of illegal drugs;

WHEREAS, the said K9 Team, once deployed, shall serve as organic personnel of the Pavia Municipal Police Station, and shall significantly augment the station's operational capability;

WHEREAS, the implementation of this undertaking requires the execution of a Memorandum of Agreement (MOA) between the Municipality of Pavia and the Iloilo Police Provincial Office (IPPO), Philippine National Police (PNP);

WHEREAS, there is a need to authorize the Municipal Mayor, Honorable Laurence Anthony G. Gorriceta, to represent the Municipality of Pavia, Iloilo and to enter and sign the Memorandum of Agreement (MOA) for the said purpose;

WHEREAS, the Sangguniang Bayan Office shall be furnished the signed copy of the said MOA for documentation purposes;


NOW, THEREFORE, on motion of Honorable Joe Fritz C. Collado, which was duly seconded by Honorable Leonardo L. Belasa;
