RESOLUTION 2025-200

RESOLUTION AUTHORIZING THE VICE MAYOR/PRESIDING OFFICER OF THE SANGGUNIANG BAYAN TO USE SAVINGS FOR AUGMENTATION IN ACCORDANCE WITH THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, in accordance with Section 336 of Republic Act No. 7160 or the Local Government Code of 1991, the Vice Mayor/Presiding Officer of the Sangguniang Bayan is authorized to augment any item in the approved annual budget from savings in other items within the same expense class of their respective appropriations;

WHEREAS, for this purpose, "savings" refer to portions or balances of any programmed appropriation free from any obligation or encumbrance still available after the satisfactory completion or unavoidable discontinuance or abandonment of the work, activity, or purpose for which the appropriation is authorized, or arising from unpaid compensation and related costs pertaining to vacant positions and leaves of absence without pay;

WHEREAS, "Augmentation" implies the existence in the budget of an item, project, activity, or purpose with an appropriation which, upon implementation or subsequent evaluation of needed resources, is determined to be deficient.

WHEREAS, at the Sangguniang Bayan Office, there is a need for augmentation of the budgetary allocation for deficient appropriation within Personnel Services for the following:

- Representation and Travel Allowance (RATA)
- 14th Month Pay
- CNA
- SRI
- PBB

WHEREAS, the said amount is proposed to be sourced from the Terminal Leave Benefit, which has been declared as savings since there is no anticipated need for the said allocation until December 31, 2025;

WHEREAS, the augmentation is necessary to support various official activities and engagements of the Sangguniang Bayan Office, ensuring the efficient implementation of our programs and the smooth conduct of mandated functions;

NOW THEREFORE, on motion of Honorable Jo Jan Paul J. Peñol, and duly seconded by Ariel B. Gerada;



RESOLVED FURTHER, that copies of this resolution be forwarded to all concerned for information and appropriate action.


