RESOLUTION ADOPTING MUNICIPAL DEVELOPMENT COUNCIL (MDC) RESOLUTION NO. 2025-12, ENTITLED "A RESOLUTION APPROVING THE SUPPLEMENTAL 5 ANNUAL INVESTMENT PROGRAM FOR CALENDAR YEAR 2025 PROGRAMS, PROJECTS, AND ACTIVITIES (P/P/As) – PROVISION FOR INCENTIVES, GRATUITY PAY, BONUSES, AND OTHER AUTHORIZED BENEFITS IN THE AMOUNT OF EIGHTEEN MILLION FOUR HUNDRED TEN THOUSAND PESOS (PHP 18,410,000.00) OF THE MUNICIPALITY OF PAVIA, ILOILO.

WHEREAS, the Municipal Development Council (MDC) of the Municipality of Pavia, Iloilo, pursuant to existing laws, rules, and regulations, approved MDC Resolution No. 2025-12 endorsing the Supplemental 5 Annual Investment Program (AIP) for Calendar Year 2025;

WHEREAS, the said Supplemental 5 Annual Investment Program covers Programs, Projects, and Activities (P/P/As) specifically providing for incentives, gratuity pay, bonuses, and other authorized benefits for municipal officials and employees, in the total amount of Eighteen Million Four Hundred Ten Thousand Pesos (PHP 18,410,000.00);

WHEREAS, the inclusion of these P/P/As in the Annual Investment Program is necessary to ensure lawful funding, proper budgeting, and compliance with existing civil service, budgeting, and auditing laws and regulations;

WHEREAS, the Supplemental 5 AIP CY 2025 is consistent with applicable policies and guidelines on the grant of incentives and benefits and is aligned with the fiscal capacity and development priorities of the Municipality of Pavia, Iloilo;

WHEREAS, the approval and adoption of the Sangguniang Bayan are required to authorize the implementation of the said Supplemental 5 Annual Investment Program, subject to existing rules and regulations;

NOW THEREFORE, on motion of Honorable Jo Jan Paul J. Peñol, and duly seconded by Honorable Kervin Matthew G. Zaladriaga,


