RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT BETWEEN THE MUNICIPALITY OF PAVIA, ILOILO AND THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD) FOR THE IMPLEMENTATION OF THE COMPREHENSIVE SOCIAL WELFARE AND PROTECTION PROGRAM FOR THE PERIOD 2026–2028.

WHEREAS, the Municipality of Pavia, Iloilo is committed to promoting social protection, poverty alleviation, and inclusive development through responsive and sustainable social welfare programs for its constituents, especially the poor, vulnerable, and marginalized sectors;

WHEREAS, the Department of Social Welfare and Development (DSWD), as the primary government agency mandated to develop, implement, and coordinate social protection and welfare programs, has extended support to local government units in implementing comprehensive and integrated social welfare interventions;

WHEREAS, the Municipality of Pavia, Iloilo and the Department of Social Welfare and Development have agreed to enter into a Memorandum of Agreement (MOA) for the implementation of the Comprehensive Social Welfare and Protection Program covering the period 2026–2028, defining the respective roles, responsibilities, and commitments of the parties;

WHEREAS, the said MOA aims to strengthen the delivery of social welfare services, enhance institutional capacities, and ensure effective coordination in the implementation of social protection programs within the Municipality of Pavia;

WHEREAS, the approval of the Sangguniang Bayan is necessary to authorize the Municipality of Pavia, Iloilo to enter into the said Memorandum of Agreement and to ensure the proper implementation of the program, subject to existing laws, rules, and regulations;

NOW THEREFORE, on motion of Honorable Rhia B. Sotomil, and duly seconded by Honorable Kervin Matthew G. Zaldarriaga,


