RESOLUTION APPROVING THE MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE MUNICIPALITY OF PAVIA, ILOILO AND PAVIA NATIONAL HIGH SCHOOL FOR THE IMPLEMENTATION OF BULIG SA PAGTUON PROGRAM FOR SCHOOL YEAR 2025-2026 AND FURTHER AUTHORIZING HONORABLE LAURENCE ANTHONY G. GORRICETA, MUNICIPAL MAYOR TO SIGN THE SAME.

WHEREAS, presented for consideration of the body, and referred to the SB Committee on Education is the endorsement for the above-mentioned measure for appropriate action;

WHEREAS, the responsibilities of both parties, and the terms and conditions are stipulated in the MOA, attached as "ANNEX A";

WHEREAS, for 20 years, the Bulig sa Pagtuon Program has assisted Pavianhons especially the less-privileged to return to school and finally earn a diploma;

WHEREAS, the Bulig sa Pagtuon Program has been institutionalized, by virtue of Municipal Ordinance No. 2024-45;

WHEREAS, this year, the LGU has committed P690.00 per student for the following:

- School Publication P300.00
- Support to the Scouting Program 20.00
- Student Identification Card 100.00
- Library, Reading, and Reference Materials Review Materials, and Testing Fee 150.00
- Clinic/Medical/Dental Supplies and Equipment 50.00
- Support to Teen Center/Guidance Services 20.00
- Support to Supreme Secondary Learner Govt 50.00

WHEREAS, the Sangguniang Bayan Office shall be furnished a copy of the signed MOA for documentation purposes;

WHEREAS, the Sangguniang Bayan of Pavia, Iloilo recommended for the approval of the above-mentioned resolution as indicated in Committee Report 2025-156 of the SB Committee on Education dated December 15, 2025;

NOW, THEREFORE, on motion of Honorable Jo Jan Paul J. Peñol, and duly seconded by Honorable Ariel B. Gerada;


