

**MUNICIPAL ORDINANCE 2026-01**

**ORDINANCE EXTENDING THE DEADLINE FOR BUSINESS PERMIT RENEWALS UNTIL JANUARY 30, 2026 TO PROVIDE BUSINESS WITHIN THE MUNICIPALITY OF PAVIA, ILOILO AMPLE TIME TO COMPLY WITH RENEWAL REQUIREMENTS AT ROBINSON'S PLACE-PAVIA, BARANGAY UNGKA II, PAVIA, ILOILO.**

**WHEREAS**, as represented by the Municipal Treasurer – Ms. Caroline Teruel and endorsed by the Local Chief Executive, there is a need for extension of the renewal of business permits until January 30, 2026;

**WHEREAS**, the extension aims to provide business taxpayers ample time to complete the processing of their business permit applications, settle their corresponding business taxes, particularly those who may have experienced delays due to documentary requirements such as processing of check payments considering the volume of applicants during the renewal period;

**WHEREAS**, this will help promote voluntary compliance, improve taxpayer relations, and ultimately enhance revenue collection without imposing undue burden on the business sector;

**NOW THEREFORE, BE IT ORDAINED BY THE SANGGUNIANG BAYAN OF PAVIA, ILOILO, BY VIRTUE OF THE POWERS VESTED IN IT BY LAW, IN SESSION ASSEMBLED, THAT:**

**Section 1. Title.** *ORDINANCE EXTENDING THE DEADLINE FOR BUSINESS PERMIT RENEWALS UNTIL JANUARY 30, 2026 TO PROVIDE BUSINESS WITHIN THE MUNICIPALITY OF PAVIA, ILOILO AMPLE TIME TO COMPLY WITH RENEWAL REQUIREMENTS AT ROBINSON'S PLACE-PAVIA, BARANGAY UNGKA II, PAVIA, ILOILO*, be approved.

**Section 2. Repealing Clause.** All ordinances, as well as pertinent rules and regulations thereof, which are inconsistent with the provisions of this ordinance are hereby repealed or amended accordingly.

**Section 3. Effectivity.** This Ordinance shall take effect immediately after complying the requirements provided for in the Local Government Code.

**BE IT ORDAINED FURTHER**, to furnish copies of this Ordinance 2026-01 to all concerned agencies for information and appropriate action.


